

Terms and Conditions of Sale

1. Preamble

1.1. This marketplace platform (hereinafter referred to as "the Platform") is operated by STOREMOOV, a company registered in mainland France, whose registered office is located at 68 Avenue de Fontainebleau 94270 Le Kremlin-Bicêtre, registered in the Créteil Trade and Companies Register under number 912 258 712, intracommunity VAT number FR09912258712..

1.2. The Platform provides a space where third-party sellers (hereinafter referred to as "Sellers") can offer their products or services for sale, and where users (hereinafter referred to as "Buyers") can purchase these products or services. A "Buyer" may also become a "Seller" if he/she offers his/her (generally second-hand) equipment for sale.

1.3. These General Terms and Conditions of Sale (hereinafter referred to as "GTCS") govern the contractual relationship between the Platform, the Sellers and the Buyers.

2. Platform access

2.1. Access to the Platform is open to any individual or legal entity acting in the course of its professional or commercial activity.

2.2. Buyers and Sellers must register on the Platform and accept these Terms and Conditions as well as the specific conditions in order to be able to offer their products or services for sale.

3. Platform responsibilities

3.1. The Platform provides an online sales space for Sellers and facilitates transactions between Sellers and Buyers.

3.2. The Platform is not a party to transactions between Sellers and Buyers and assumes no responsibility for the quality of products or services offered by Sellers, their delivery, or any dispute between the parties.

4. Seller's responsibilities

4.1. Sellers are responsible for the accurate description of their products or services, prices and delivery times.

4.2. Sellers must comply with the laws and regulations in force in metropolitan France and guarantee that their products or services are not counterfeit.

5. Orders and payments

5.1. Buyers place orders directly with Sellers via the Platform.

5.2. Payments are processed by the Platform or a third-party payment service provider. The Platform may retain a commission on sales, in accordance with the terms and conditions specific to the Sellers.

6. Delivery

6.1. Delivery terms are defined by the Sellers and must be clearly indicated in their advertisements.

6.2. The Sellers are responsible for the timely delivery in good condition of the products or services sold.

7. Right of withdrawal

7.1. Purchasers have a right of withdrawal in accordance with current legislation. The procedures for exercising this right are specified in the Sellers' General Terms and Conditions of Sale.

8. Disputes

8.1. In the event of a dispute between a Seller and a Buyer, the parties are encouraged to resolve the dispute amicably. If this fails, the parties may have recourse to the courts under French law.

9. Modification of the Terms and Conditions of Sale

9.1. The Platform reserves the right to modify these Terms and Conditions of Sale at any time. Amendments will be published on the Platform and will apply to subsequent transactions.
